The following amendment to the tender documents is effective immediately. This addendum shall form part of the contract documents.

General

1. Reference Drawing E1 - Lower Level & Upper-Level Electrical Plans:

- 1. Supply and install breakers for mechanical equipment in Panel DP located in the lower-level furnace room as described below:
 - a. Connect HC-1A to a 3P/25A breaker.
 - b. Connect HC-1B to a 3P/20A breaker.
 - c. Connect HC-2A to a 3P/20A breaker.
 - d. Connect HC-2B to a 3P/15A breaker.
 - e. Connect H-1 to a 3P/20A breaker.
 - f. Connect H-2 to a 3P/20A breaker.
- 2. Supply and install a 1P/15A breaker in Panel A for WS-1.
- 3. Connect P-1 to the nearest 1P/15A circuit.

2. Reference Drawing E2 - Roof Plan, Details & Specifications:

- 1. Supply and install breakers for mechanical equipment in Panel DP located in the lower-level furnace room as described below:
 - a. Connect ERV-1 to a 3P/15A breaker.
 - b. Connect ERV-2 to a 3P/15A breaker.
- 2. Supply and install a 1P/20A breaker in Panel B in Upper-level Janitors Closet (026) for the rooftop receptacle.
- Supply and install a duct-type smoke detector in the supply duct of ERV-1.
 Connect to the existing fire alarm system and provide verification. Supply and install an addressable fire alarm relay to shut the ERV down upon activation of fire alarm.
