Please provide a price to print the 2023 Tourism PEI Literature Kits Envelopes as outlined below. The deadline for delivery of finished envelopes is March 15, 2023 and prices quoted are to be valid until April 1, 2023. Tourism PEI will not accept changes to quotations submitted (except for paper stock increases which require 30-day notice with correspondence from the paper mill).

Quality of printing is very important and the selected printer may be required to supply samples to show their level of printing quality. Selection of printer is not based solely on price; although price is a big factor in the decision. The lowest or any bid not necessarily accepted. If using sub-contractors, please specify. Prior to selection of printer, details concerning availability and suitability of specified paper stock, production scheduling and artwork requirements will be finalized. Refer to sample illustration below of existing Tourism PEI Envelope design. The window size is 1.5" x 4" to accommodate an addressed letter which is inserted into the envelope. Note that the paper specified is FSC-Certified stock.

Bleeds on all four sides.

equivalent), scored with permanent self-seal flap.


