The Corporation will notify the selected Proponent in writing. The selected Proponent shall execute the Agreement in the form attached as Appendix A to this RFP and satisfy any other applicable conditions of this RFP within thirty (30) days of notice of selection.

## **Proponent Questions:**

## Question #1 – Can a bathymetric survey be provided?

Response: An updated traffic study including port dimensions and bearing capacity has been amended to the RFP Appendix E. It is available upon request to the RFP contact.

## Question #2 - Can Storage yard drawing be provided?

Response: Storage yard is a recently vacated gravel pit storage. Details on this will follow as soon as they become available. For clarity, providing an adequate interim storage space is not the responsibility of proponents. If there are alternative suggestions or methodologies proposed, they will be considered however, at this time, the Corporation would provide this location to the Proponent.

The corporation will provide the interim storage site with adequate space and bearing capacity. Delivery sequence of all components has not been finalized but will be provided as soon as possible.

**Question #3 – Can Storage yard geotechnical survey result?** To be provided following contract award. Response: Responsibility of ensuring bearing capacity is adequate at the interim storage location is the responsibility of the Corporation.

## Question #4 - Where is your responsibility starts on the ship, from stow or from under hook?

### Response: Under hook

### Question #5 – Can the vessel/load out schedule be provided?

Response: All components will require multiple vessels with first deliveries arrive early June 2025 and final deliveries being made within 4 weeks of first port delivery. A precise schedule and vessel component sequence will be provided as soon as the information is available. We anticipate these details to be finalized before contract signing.
